**Subject:** Action Taken Report Called for(ATR) -806/11/7/2025.

Sir/ Madam,

The complaint/ intimation dated 14/10/2025, was placed before the Commission on 02/12/2025. Upon perusing the same, the Commission directed as follows:

An online complaint dated 14.10.2025 has been received from Deepanshu Sahu r/o Jabalpur, Madhya Pradesh in the Commission containing that:

The complainant has drawn the attention of the Commission on the incident occurred on 10.10.2025 wherein the victim named Anandu Aji, aged 24 r/o Thamplaakad, Kottayam, Kerala, committed suicide due to his mental and physical torture. It has been alleged that the accused are RSS members who are sexually abusing him since childhood.

His suicide note revealed the trauma caused by this abuse, which led to severe mental health issues. The complainant urges a thorough investigation and registration of an FIR under relevant laws including child protection statutes. They also call for government action to prevent minors from joining RSS activities and demand transparency about RSS's registration and membership.

In view of the above, the Commission is of the considered view that the allegations leveled in the complaint are serious violations of the Human Rights of the victims. Accordingly, the Registry is directed to send a copy of the complaint to the Superintendent of Police, Kottayam, Kerala to make an inquiry and submit the report expeditiously within a period of 15 days.

2. Accordingly, I am forwarding herewith a copy of the complaint/ intimation as an attachment for taking appropriate action in the matter as per the directions of the Commission. It is requested that an Action Taken Report be sent to the Commission within 2 weeks from the date of receipt of this letter.
